## About: Clouds

There isn't a more popular buzzword nowadays than “clouds” and everything related to the topic.

So, we are interested in it as well and have a good starting point. We won the 13th Microsoft Awards in the BPOS category (Business Productivity Online Suite) for migration of a customer into clouds; we are the biggest implementer in this area in the Czech Republic and we have been actively participating on the launch of the Office 365 product on the market.

We actively pursue development of our own applications for this platform as well as we are allowed to use the “Powered by Windows Azure” logo.

All in all, we can tell you a word or two about the clouds, what it is and why to even think about it.

There are three basic types of clouds:

- IaaS (Infrastructure as a Service) with the biggest provider Amazon. It gives you plenty of virtual servers on which you can install anything. On the other hand, you have to manage it on your own;
- PaaS (Platform as a Service) where Google and Microsoft are the known players. On top of a hardware, you get a software as well, and with Microsoft Azure you get also their powerful SQL database;
- SaaS (Software as a Service) where the most known representative is probably the Salesforce, and this is exactly the segment where we are heading to with our **BOSS** and BRight products.

Having **BOSS** in the cloud means, for a lot of companies, significantly lower TCO. There are no licensing payments, long implementation work or need for integration into the

existing environment. You just pay the monthly payment based on your actual usage of the system. You can freely change the modules you use or the number of users you have. It is very similar to the model of mobile phones charges.

The length of standard implementation was shortened to the minimum. We have dedicated environment for each customer, which helps to minimize your concerns about the safety of your data. The whole Windows Azure infrastructure would have to be compromised for another customer to get access to your data.

Our flexibility to make changes tailored to your needs isn't reduced when implementing in the cloud. We are still able to make changes as you need them; they are just paid for on top of the regular price.

## Focus on: Directives

To make sure that people are familiar with the relevant guidelines and at the same time be assured that they are familiar with all they need to know - not a simple task, however, easily resolved with the module *Directives*.

The module allows you to enter the directives in the system, create test questions to check the user's knowledge (optional), choose its approval process and identify the target groups for whom the directive is addressed. You can define specific personnel across the organizational units or personnel with specific competencies as the target recipients.

Upon approval of the directive and its entry into force, test questions for all affected employees are automatically generated. When generating tests, it is possible to specify the number of questions to ensure that every test is unique. Additionally, the application

monitors the validity of the tests and will generate a new one before the current version expiry date (for example, if workers are to be tested each year). The application also monitors changes in the organizational structure and automatically generates tests for new workers or workers who have changed their position.

Employees are assigned the task to become familiar with the directive and complete the test. The test is automatically evaluated upon its completion. An employee can also always look at the directives related to him and refresh the text.

## News

Long time validity of electronic documents is another popular topic, especially with the Data Boxes system in the Czech Republic. The interesting part is that the experts and the government cannot come to an agreement. We have respected the government's point of view for a long time and now we are coming to you with an add-on which enables us to respect the experts' point of view.

The government point of view is simple – what was passed through the ISDS system is valid indefinitely. It is enough to save the whole ZFO file. However, you will run into problems quite quickly - first attempted conversion of a document via the CzechPoint after signature expiration, and it fails.

The expiration date of signature is the problem which the experts have been pointing out. It is limited on purpose - to eliminate the risk of compromising the signature using the growing power of computers. So, they recommend attaching a time stamp along with the signature and before the expiration date of the time stamp adding a new one. This solution is somewhat financially demanding as you have to pay for each time stamp, but the proof of validity can be well worth it.

Our add-on for the *Data Boxes* module provides you with the automatic check of signatures on incoming PDF documents, time stamping in regular intervals and ability to sign outgoing documents.
